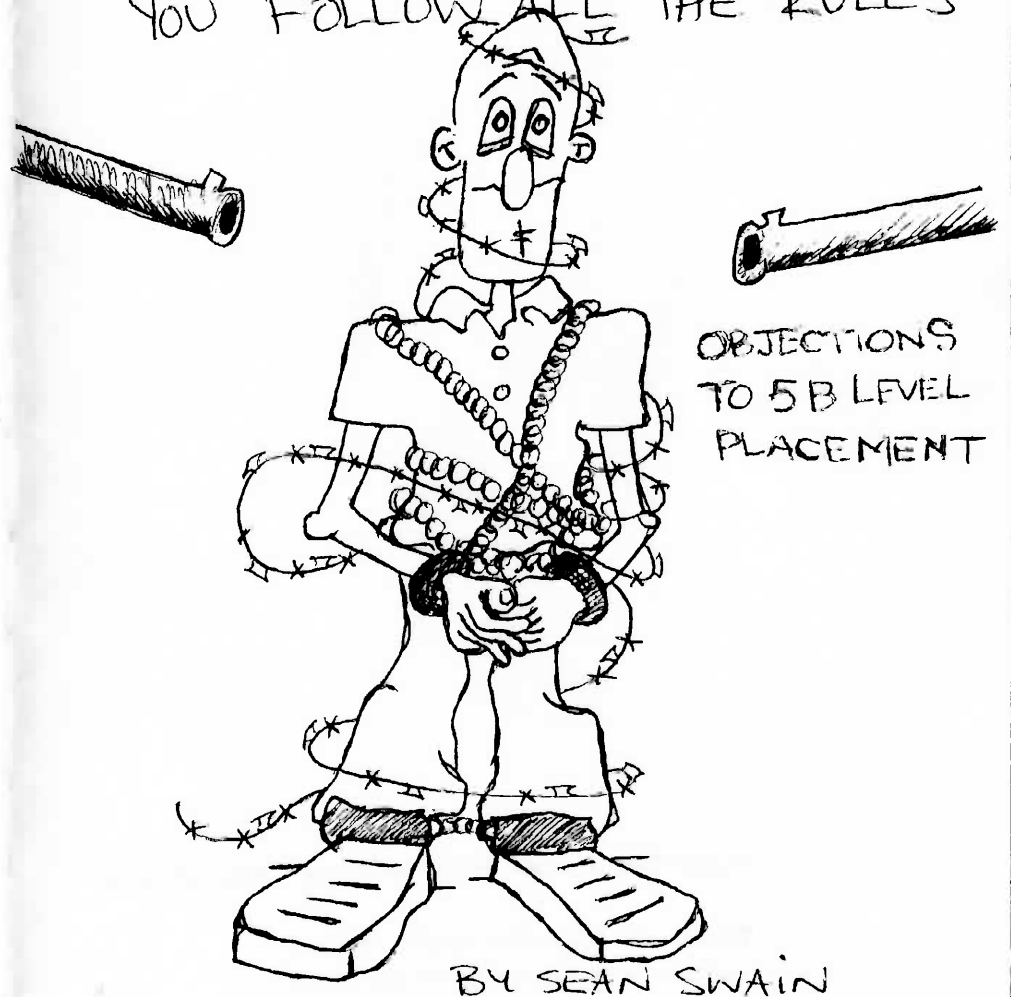

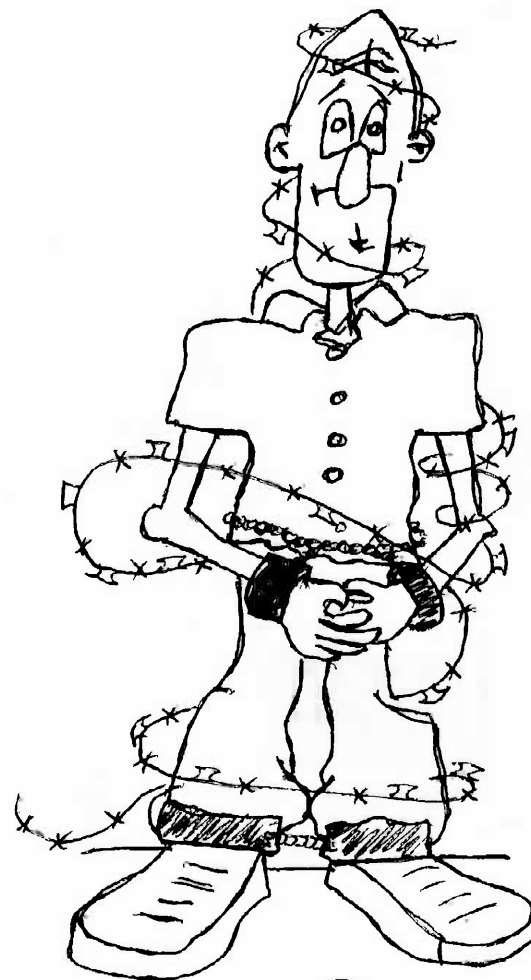

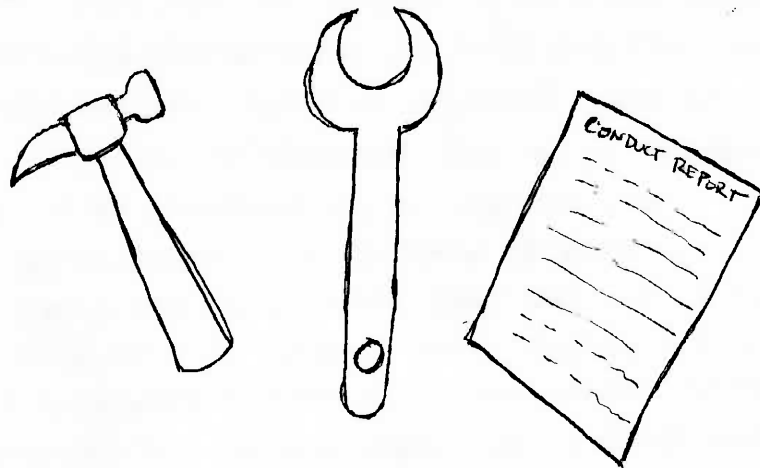
LIES ARE THE TOOLS ANGELA HUNSINGER USED. READ MY OBJECTIONS.

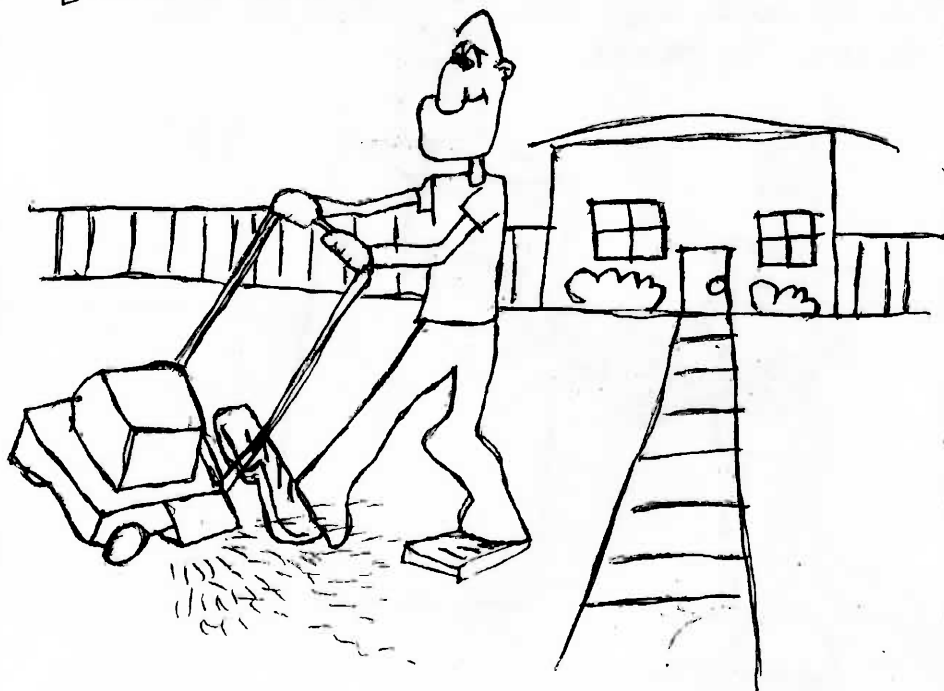

EVERYONE KNOWS IT.



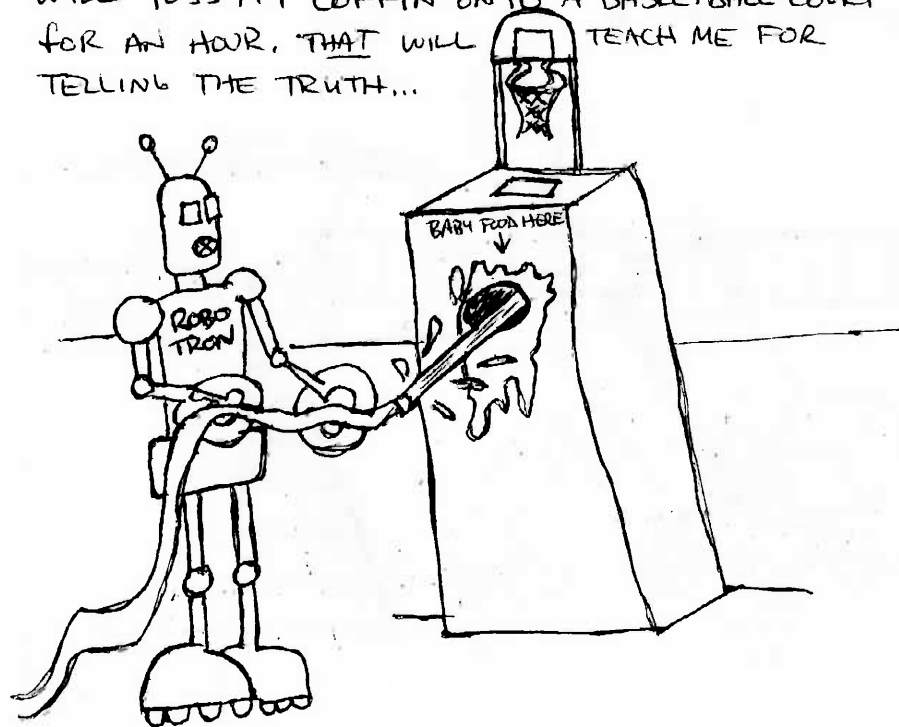

THAT TAUGHT ME A VALUABLE LESSON ABOUT TELLING THE TRUTH...

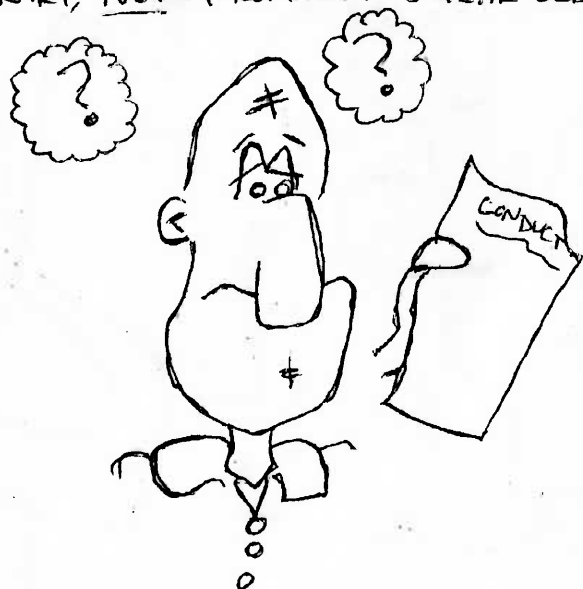

ON THE 30TH DAY OF A 21-DAY INVESTIGATION, I WAS GIVEN A CONDUCT REPORT ACCUSING ME OF BEING THE LEADER OF THE ARMY OF THE 12 MONKEYS. THE CONDUCT SAID I WROTE AN ARTICLE (BUT MISREPRESENTED IT); SAID I WROTE AN ANGRY LETTER TO A FRIEND (BUT LIED + MADE IT SOUND LIKE A CONFESSION); AND SAID I HAD A TATTOO.

BUT I'VE GOT 29 TATTOOS.

THE CLOCK ON MY TATTOO READS 12:21 AND DOESN'T SAY, "THEY'RE COMING!" THE LOGO USED BY THE BANANA GANG HAS A CLOCK SET AT 3:00 AND SAYS, "THEY'RE COMING," BECAUSE THEY GOT THEIR LOGO FROM THE VIDEO IN THE MANCI VIDEO LIBRARY, NOT FROM MY 3 YEAR-OLD TATTOO.



WHAT'S MISSING FROM THE CONDUCT REPORT IS ANY EXPLANATION AS TO HOW AN ARTICLE (THAT INVESTIGATOR HUNSINGER PROVABLY LIED ABOUT) AND A LETTER (THAT INVESTIGATOR HUNSINGER PROVABLY LIED ABOUT) AND A TATTOO (THAT INVESTIGATOR HUNSINGER PROVABLY LIED ABOUT) RELATES IN ANY WAY TO GANG ACTIVITY, INCITING A RIOT, OR USING MAIL IN FURTHERANCE OF CRIMINAL ACTIVITY.

WHAT'S MISSING FROM THE CONDUCT REPORT IS A DESCRIPTION OF ANY CONDUCT THAT BROKE ANY RULES.

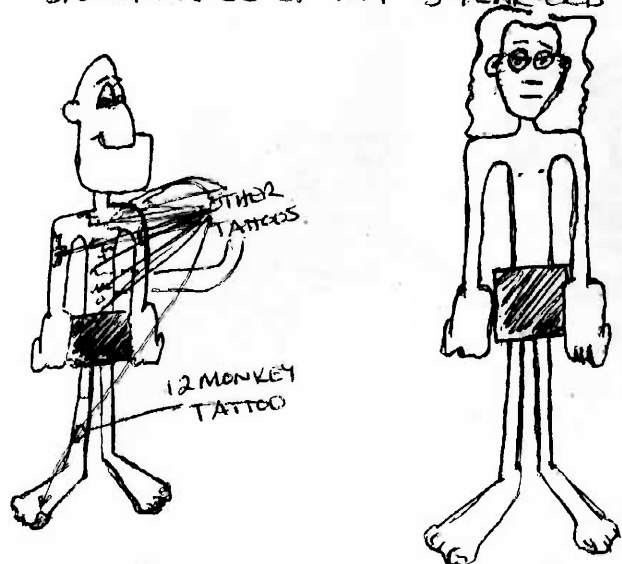


THE ARMY OF THE 12 MONKEYS IS LIKELY A MAOIST FACTION. MAOISTS HATE ANARCHISTS.

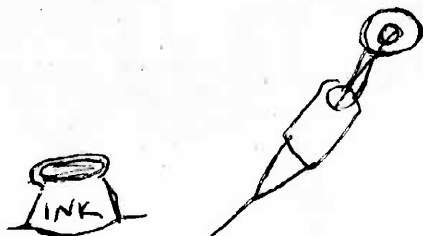
