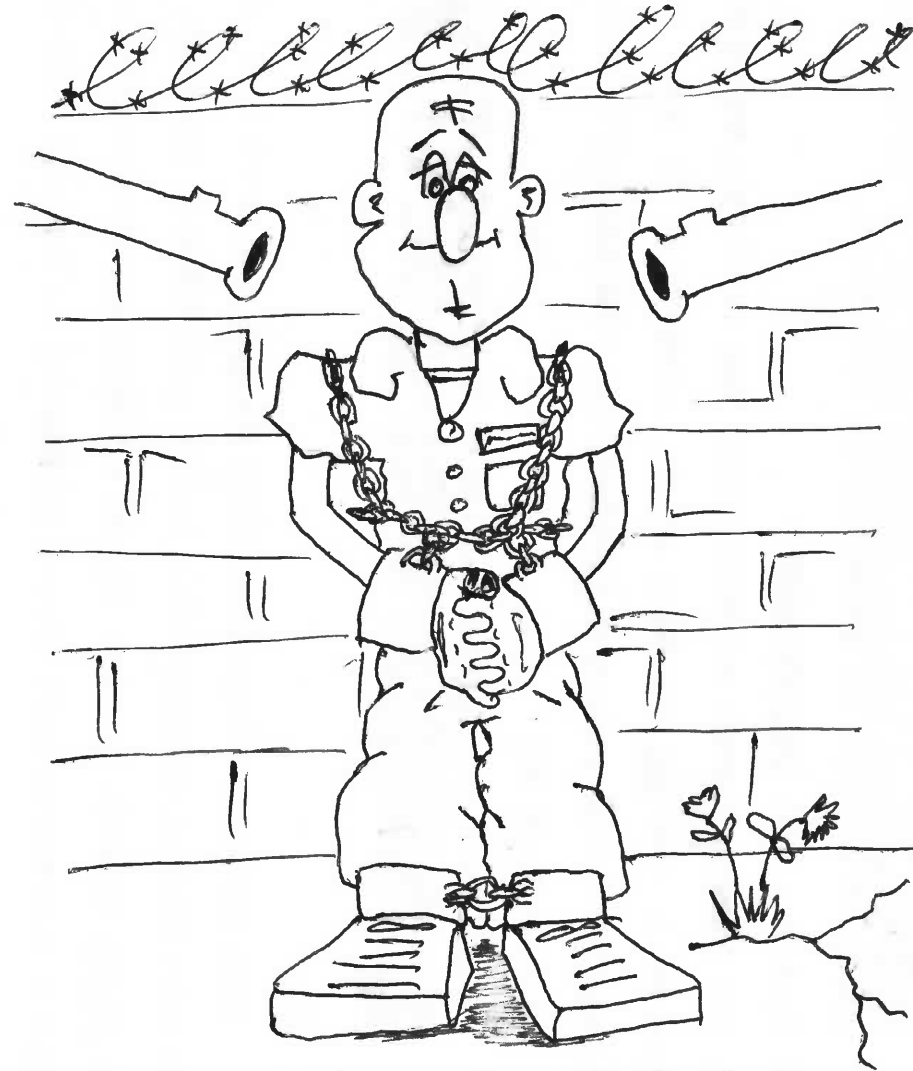

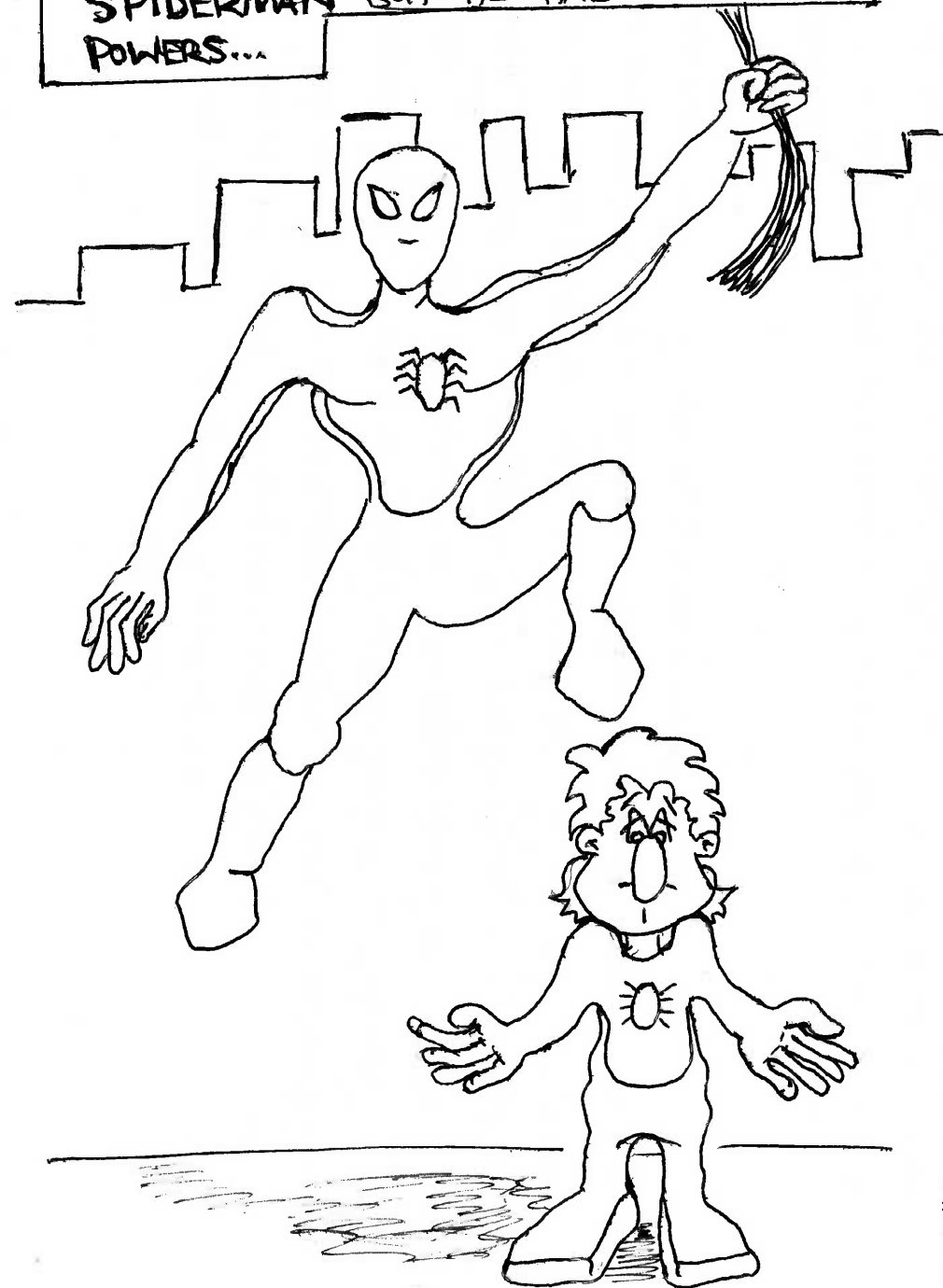

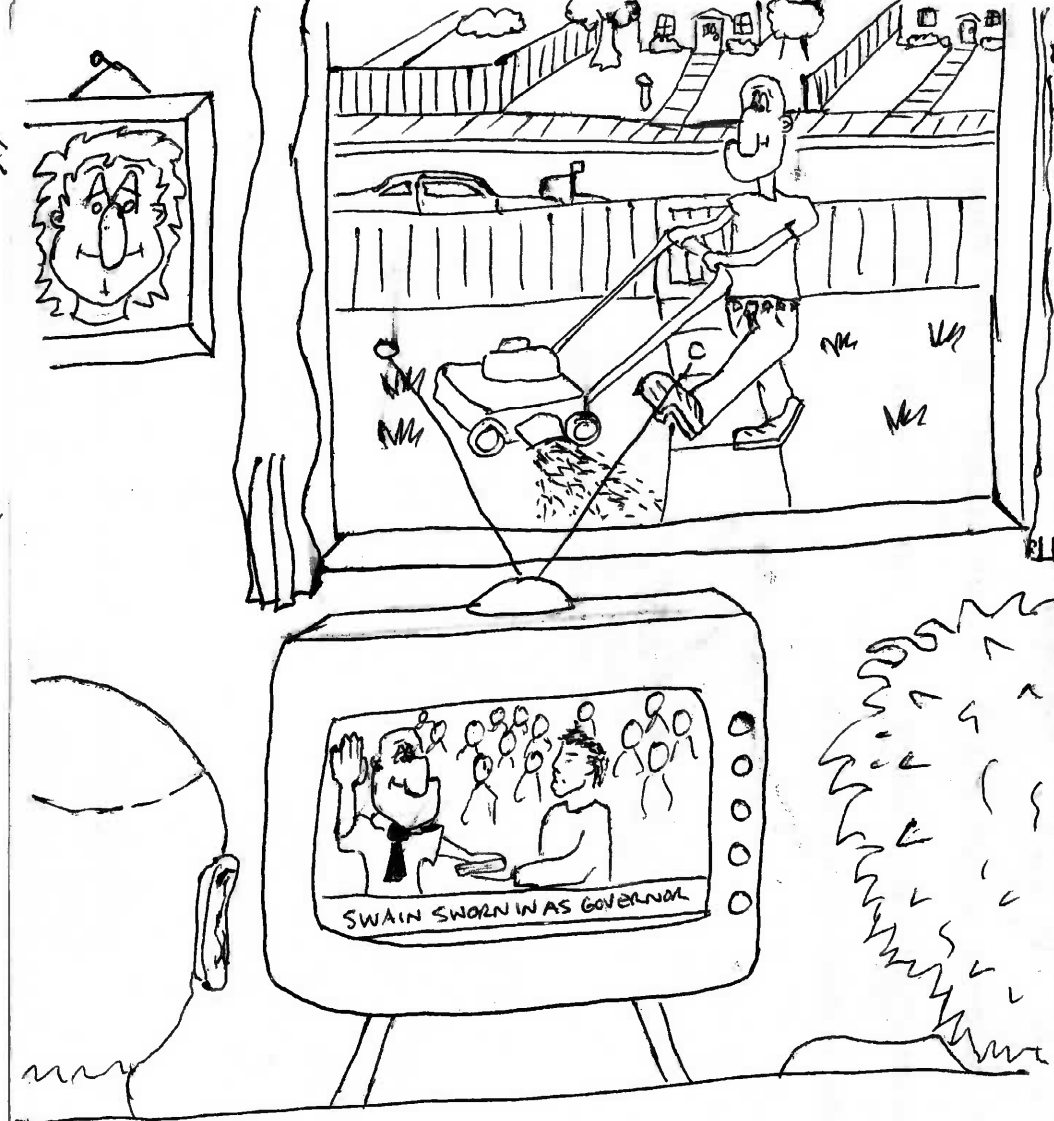


HE WORE A **SUIT** ONCE...  
AT HIS GRANDMOTHER'S FUNERAL...



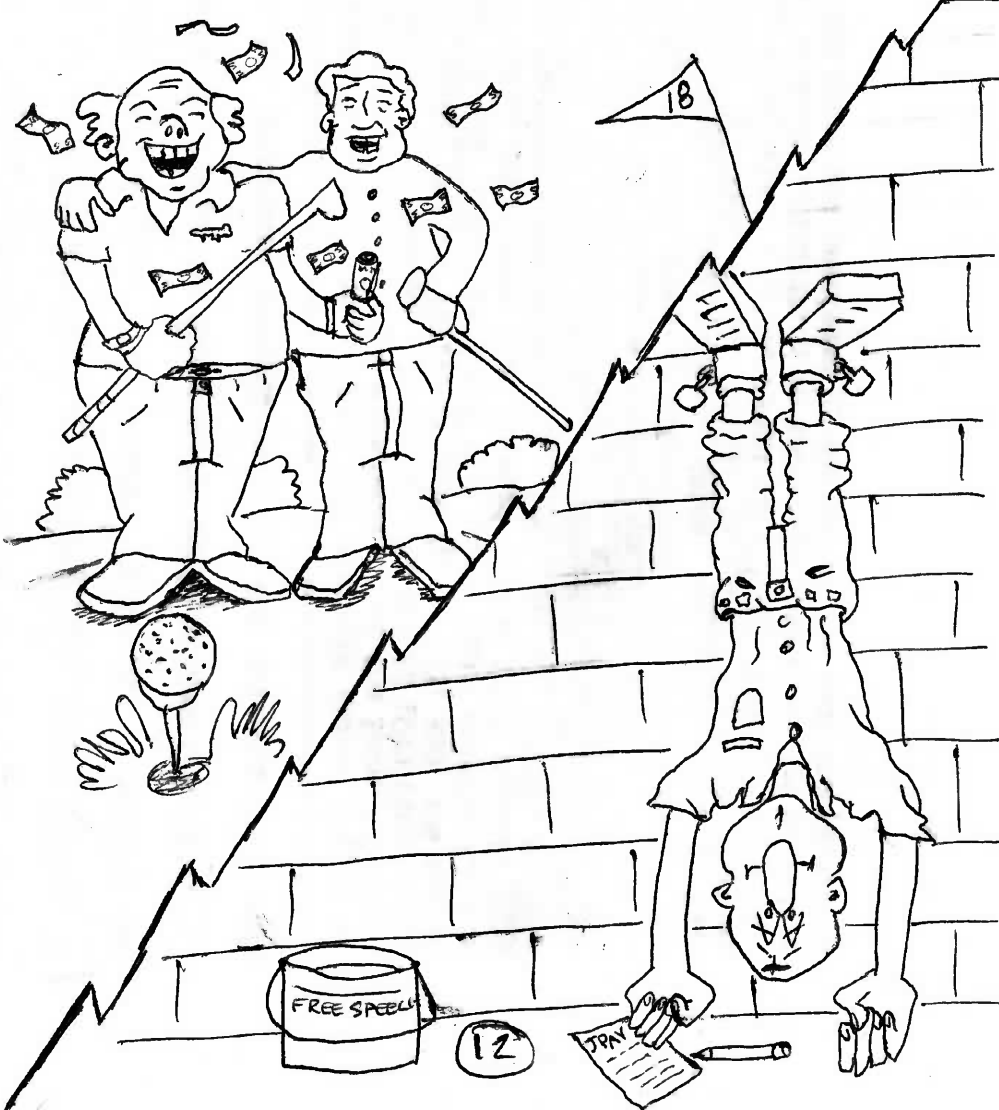

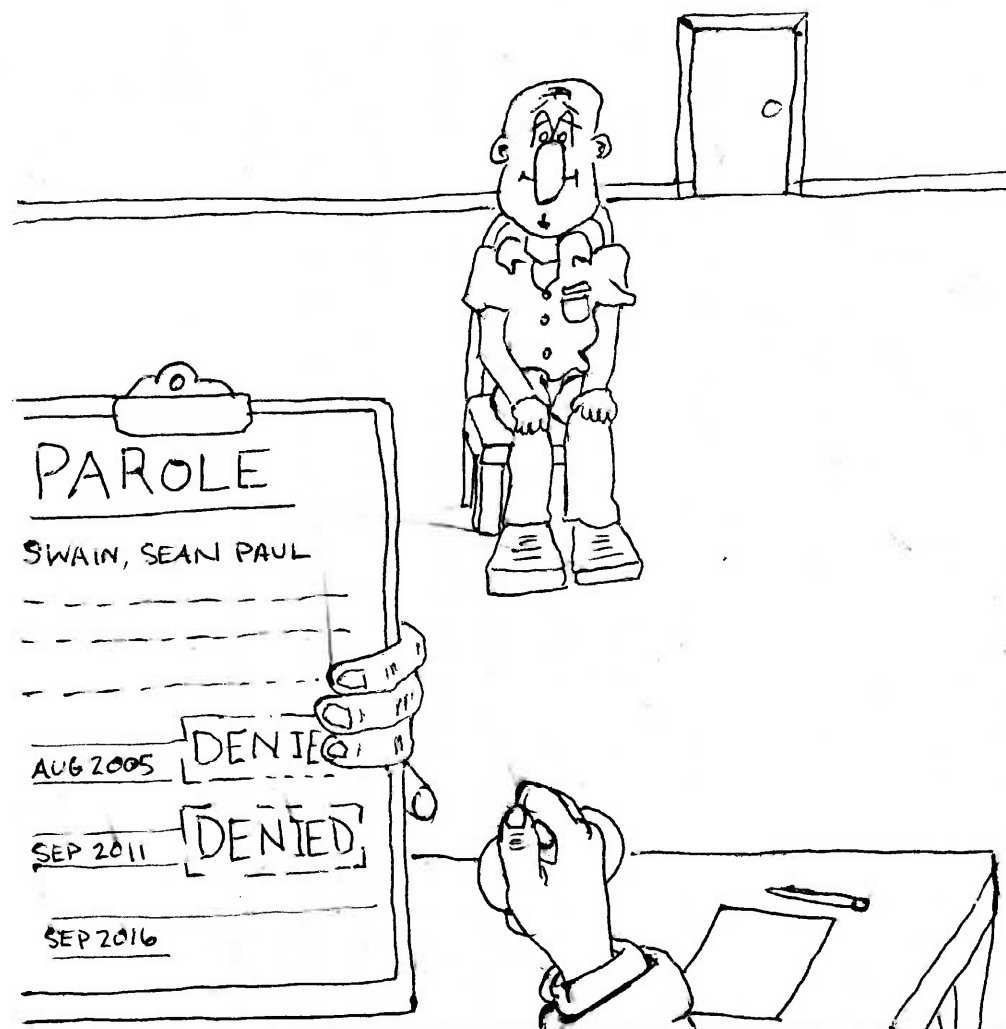

KILLED WAS THE CLERK OF COURT'S NEPHEW...

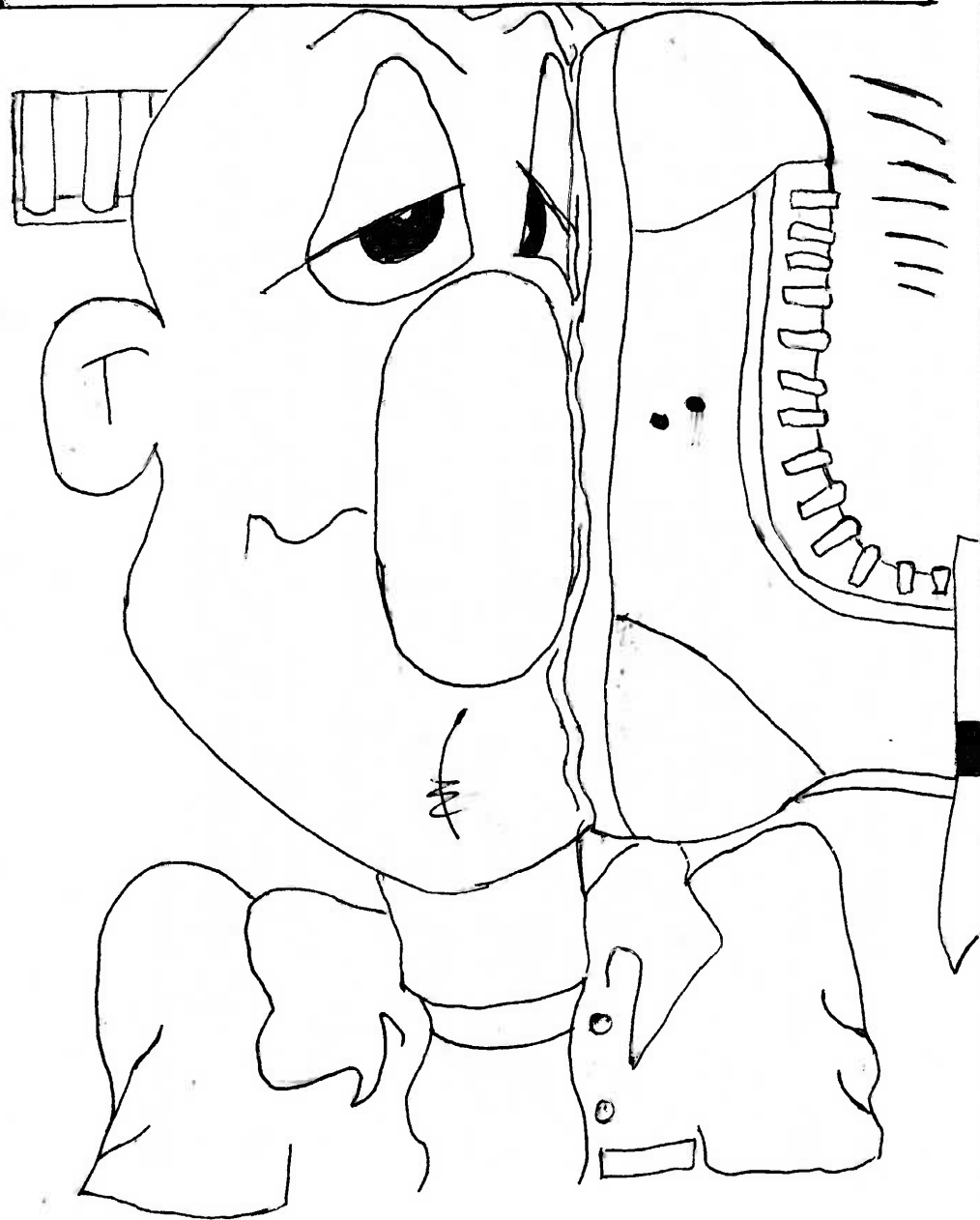
